## NOTICE TO FAMILIES

1. This Application constitutes the entire Agreement between the parent(s) or legal guardian(s) (referred to as the "Family," which term includes the singular or plural, as applicable) and Triad (referred to as the "School") regarding the Application for enrollment.
2. Do not sign this Application before you have read it or if it contains any blank spaces.
3. This Application is a legally binding instrument and is only binding when it is accepted, signed, and dated by the authorized official of the School. Please read all pages of this Application before signing.
4. You are entitled to an exact copy of this Application and any disclosure page you sign.
5. Any changes to this Agreement must be made in writing and shall not be binding on either the Family or the School unless such changes have been approved in writing by the authorized official of the School and by the Family.
6. The Family understands and agrees the student is enrolled for the entire school year.
7. The Family understands and agrees that the duties and obligations of the School under this Agreement may be suspended immediately without notice during all periods that the School is closed because of force majeure events and that the School shall not be liable for any failure to perform its obligations in connection with any part of this Agreement. Force majeure events, including, but not limited to, Acts of God, governmental action, riot, war, fire, epidemic, pandemic, civil unrest, flood, acts of terrorism, earthquake, weather, other threats to the safety of students, national emergencies, or any other cause beyond the School's reasonably foreseeable control, including, but not limited to any mechanical, electronic, or communications failure. The School will not be held liable if a force majeure situation occurs; the School's duties and obligations under this Agreement may be modified, suspended, or postponed until such time as the School, in its sole discretion, may safely re-open.

## TUITION / DEPOSITS

The tuition deposit of \$500 is non-transferable and non-refundable. The deposit is applied evenly toward tuition over the year, based on the payment plan. Tuition applies to the 180-day school year. The number of school days per month and monthly payment do not always correspond.

Tuition shall include textbooks and online access to educational programs. Tuition shall not include supplies requested in the student supply list or any other items not expressly stated herein and shall not include fees related to uniforms, field trips, laptops, school projects, musical instruments, before and after school care programs, and extracurricular activities.

Tuition is due and payable in twelve (12) monthly installments. The installment plan's first installment shall be due and payable on June 1st of the applicable school year. The remaining installments shall be due and payable on the 1st day of each month, ending May of the applicable school year.

For midyear enrollment, tuition is prorated and requires a final payment in June. Tuition adjustments are calculated using the daily rate and number of days enrolled. A book fee is calculated and charged in addition to tuition. The amount charged for the book fee is different for each class level and dependent on the timing of enrollment.

**A NON-REFUNDABLE DEPOSIT FEE OF \$500** is payable at the time of submittal of application. The deposit fee is applied evenly toward tuition over the year, based on the payment plan. **Tuition is due and payable in twelve (12) monthly installments of \$1,658.33. The installment plan's first installment shall be due and payable on June 1st of the applicable school year.** The remaining installments shall be due and payable on the 1st day of each month, ending May of the applicable school year.

## LATE / NON PAYMENT

A five percent (5%) late fee shall be assessed fifteen (15) days after the installment is due if yet to be paid. An additional accruing 5% shall be assessed on the unpaid balance each additional 30 days on the 15th of each month. The School shall terminate services after sixty (60) days with a written notice of default in payment. If a balance is due at the time of termination of services, the School reserves the right to withhold personal property, such as laptops, registration privileges, report cards and transcripts, until all financial obligations have been satisfied. After 90 days, any unpaid balance shall be reported to a collection agency. A three percent (3%) fee shall be assessed for any credit card payments. There is no early payment discount.

## REFUND / CANCELLATION

Tuition obligations are non-refundable, with the exception if a student is not accepted or the School cancels the grade or program. If the student is withdrawn, absent due to illness, unsatisfactory academic progress, disciplinary suspension, or expulsion, the School shall not refund any amounts paid of the year's tuition or fees paid, nor shall any outstanding balances be canceled.

The Family agrees to assume unconditional responsibility for the monthly tuition, fees, and, if necessary, the costs of collection thereof, including all court costs and attorney fees. The School reserves the right to withhold personal property, such as laptops, registration privileges, report cards, transcripts, and until all financial obligations have been satisfied.
